Introduction:

The Tuvalu Central Statistics Division (CSD) has compiled this International Merchandise Trade Statistics (IMTS) to provide its statistical users with the fourth quarter compilation on trade statistics in 2022. The previous quarterly IMTS reports were published on the Tuvalu CSD website.

This IMTS release coverage includes the total imports and exports statistics in accordance with the Harmonised Coding System of Tuvalu (HS) which are classified by commodity and by country. This compilation was assisted by trade data collected by the Tuvalu CSD from the Tuvalu Customs Department.

Following is the IMTS report for the fourth quarter of 2022 based on an annual trend from 2019-2021 as well as a monthly trend of the overall year from January to December 2022.

Analyses:

1. Value of Imports and Exports:

December 2022: Graph 1 depicts a consistent fluctuating flow of Tuvalu's total imports from January to December 2022 and as well as it shows Tuvalu's persistent dependence on imported products for its economic development and survival.

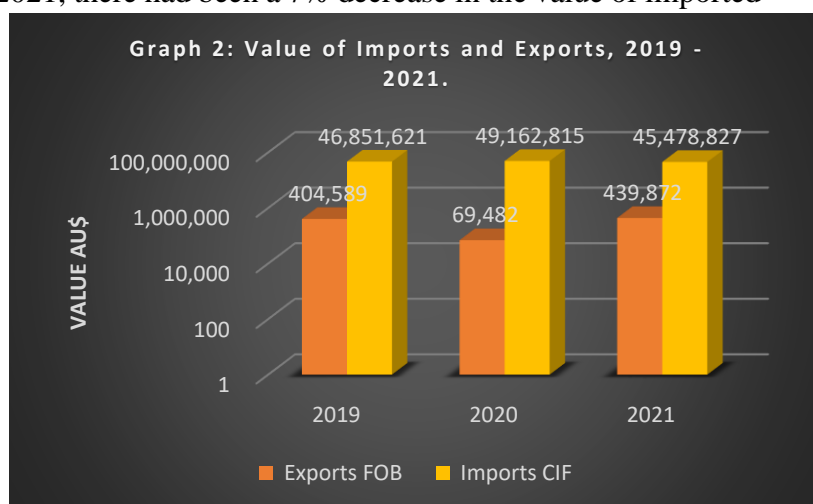
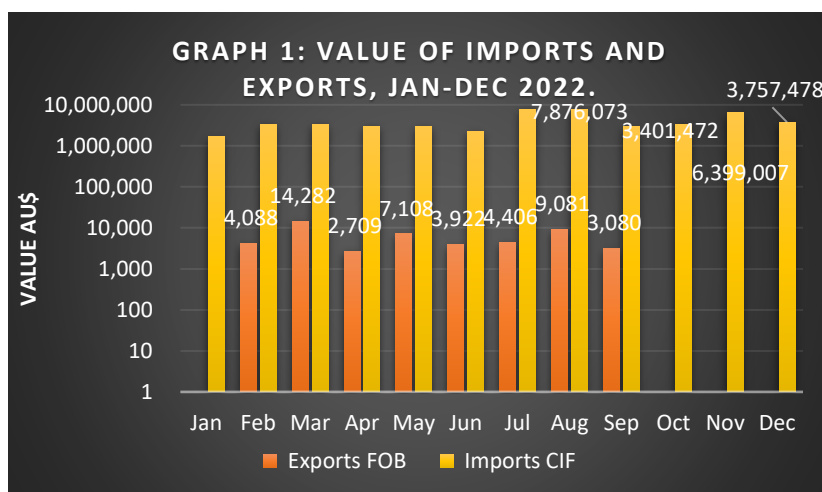
As of December 2022, Tuvalu has imported \$3,757,478 worth of goods. In August 2022, Tuvalu had the highest total imports of \$7,876,073 which decreased by 52% from August to December 2022.

**Note: These are preliminary Exports data and it shows zero total exports (Oct-Dec 22) from the Tuvalu Customs department, and re-exports data of Jet fuel re-fills have yet to be received from sources.*

2019-2021: In 2020, Tuvalu recorded its highest value of total imports, i.e., \$49,162,815. In comparison to the total imports in 2021, there had been a 7% decrease in the value of imported goods to \$45,478,827 total imports for Tuvalu.

The consecutive years illustrated in Graph 2 are evidence of Tuvalu's great reliance on imported goods which vastly assists Tuvalu's economic growth and welfare.

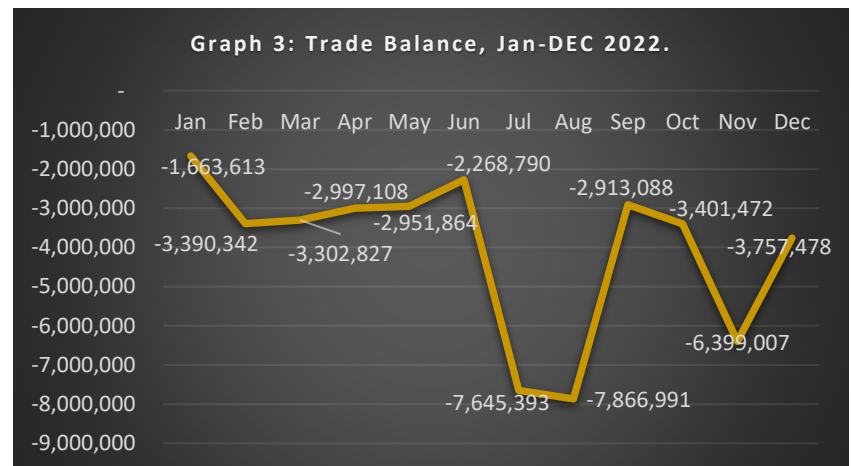
However, Tuvalu's total value of exports remained extremely low especially in 2020 when the



COVID-19 pandemic state of emergency lockdown started and the total value of exports dropped tremendously by 83%.

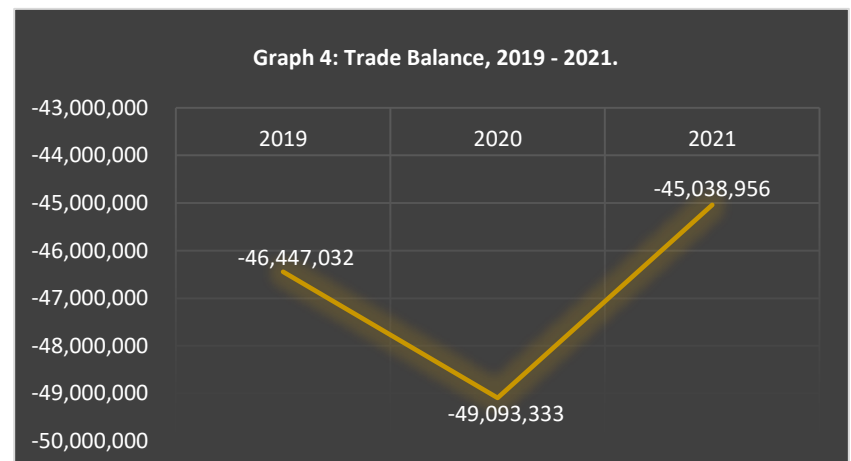
2. Balance of Trade:

December 2022: Tuvalu's trade balance remained a deficit throughout the annual year 2022. In December 2022, Tuvalu recorded a trade deficit of \$3,757,478. In comparison to the November 2022 trade deficit of \$6,399,007, the trade deficit in November decreased by \$2,641,528 or 41%.



2019-2021: The trade deficit in 2021 stood at \$45,038,956. This trade deficit in 2021 slightly decreased by \$4,054,377 or 8% from a deficit of \$49,093,333 in 2020.

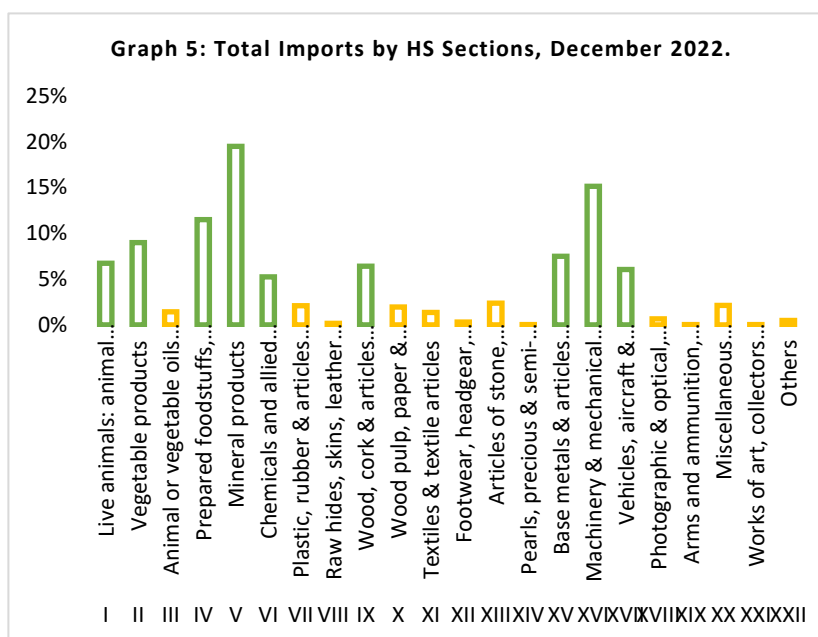
As a result of the COVID-19 pandemic country's state of emergency lockdown, the trade deficit increased for the annual year of 2020.



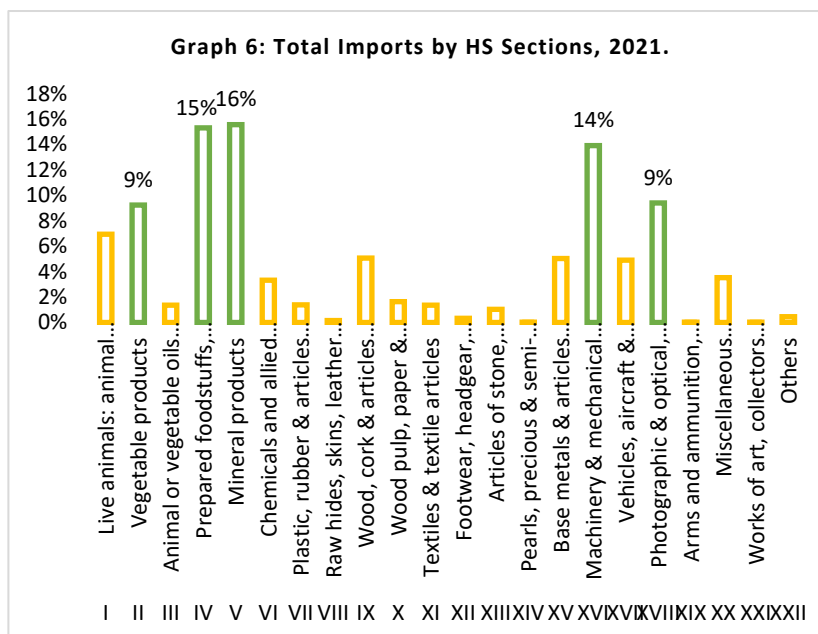
3. Performance of Imports:

December 2022: The analysis that follows emphasized the HS sections that accounted of 5% for more of Tuvalu's total imports, and it shows;

- Mineral products – 20%
- Machinery & mechanical & electrical appliances & parts thereof – 15%
- Prepared foodstuffs, beverages, spirits & tobacco – 12%
- Vegetable products – 9%
- Live animals: animal products – 7%
- Base metals & articles thereof – 7%
- Wood, cork & articles thereof & plaiting material – 6%
- Vehicles, aircraft & associated transport equipment – 6%
- Chemicals and allied products – 5%



2021: In 2021, the HS sections that were most notable for Tuvalu's total imports were **Mineral products** which accounted for **16%**, followed by **Prepared foodstuffs, beverages, spirits & tobacco** **15%**, **Machinery & mechanical & electrical appliances & parts thereof** **14%**, **Vegetable products** **9%** and **Photographic & optical, medical & surgical goods & clocks/watches & musical instruments** **9%**.



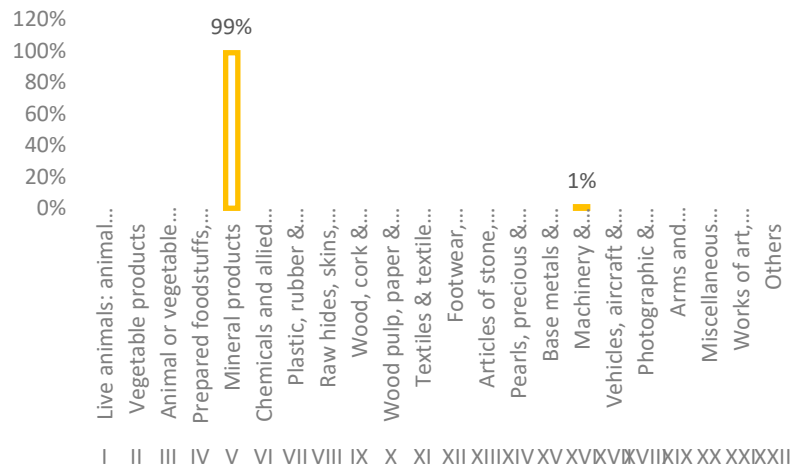
4. Performance of Exports:

December 2022: The HS section that significantly impacted Tuvalu's total exports as of 2022 was Mineral products by 99%.

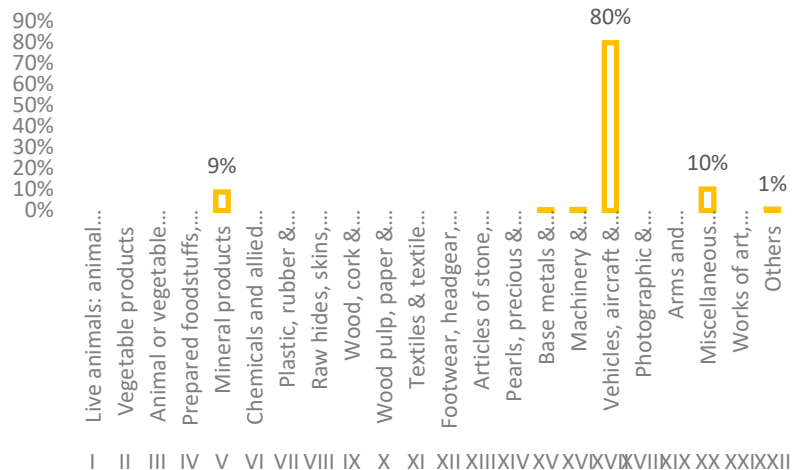
Mineral products in this case are Re-exported Jet fuel which helps refill aircraft traveling back from Tuvalu to their respective countries.

2021: In 2021, 80% of Tuvalu's total exports accounted for in the HS section of **Vehicles, aircraft & associated transport equipment**.

Graph 8: Total Exports by HS Sections, 2021.

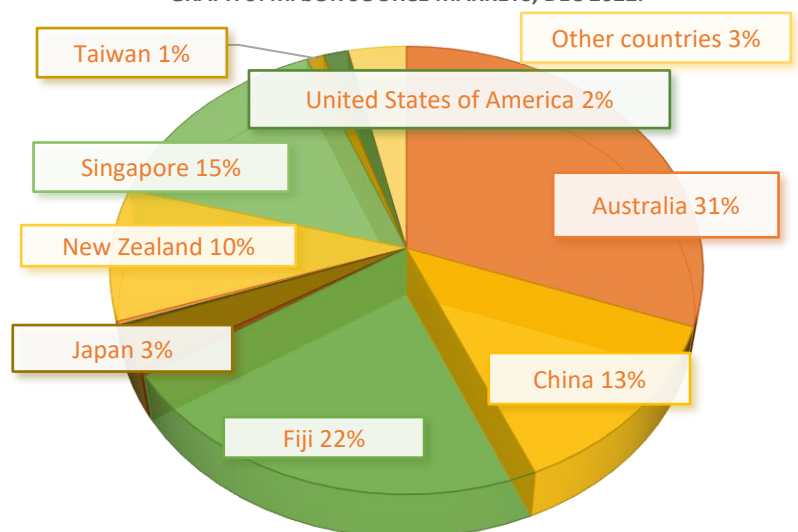


5. Direction of Trade:

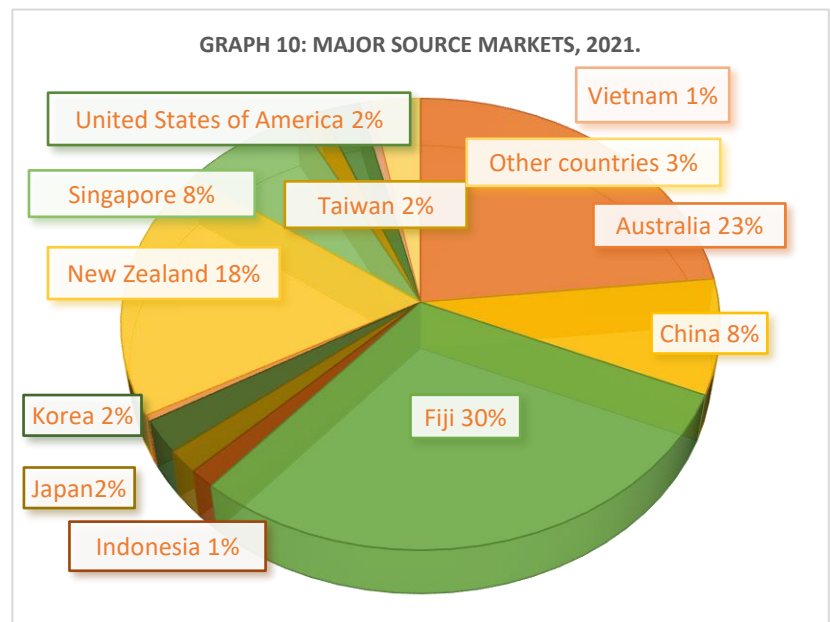
a. Major Source Markets:

December 2022: In accumulation, 63% of Tuvalu's total imports were imported from its neighbouring countries within the Pacific region such as Australia 31%, Fiji 22% and New Zealand 10%.

GRAPH 9: MAJOR SOURCE MARKETS, DEC 2022.

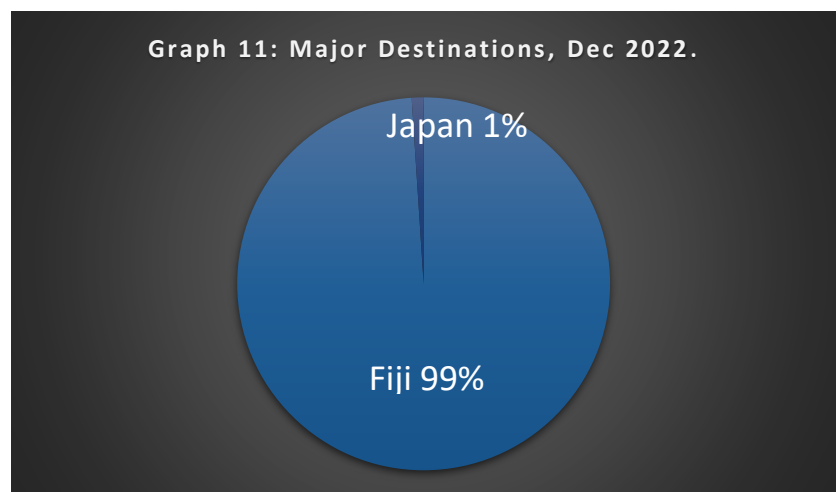


2021: As graphed in Graph 10, **Fiji** was one of the major source markets for Tuvalu in 2021 with **30%** of total imports, **24%** of total imports were attributed to **Asian countries** such as **Singapore 8%**, **Taiwan 2%**, **Korea 2%**, **Japan 2%**, **Indonesia 1%**, **Vietnam 1%** and **China 8%**.

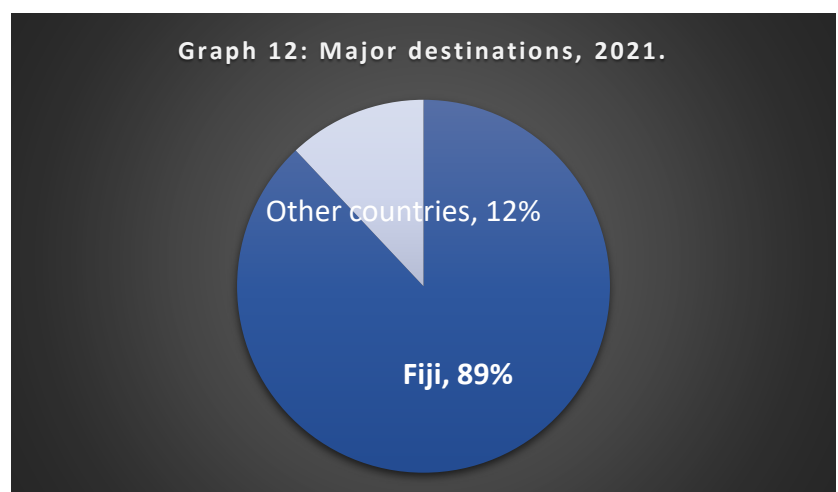


b. Major Destinations:

December 2022: As of the end of 2022, Tuvalu's major export destination was its neighbouring country of Fiji with approximately 99% of total exports. The only other country Tuvalu has exported to in 2022 was Japan with 1% of Tuvalu's total exports.



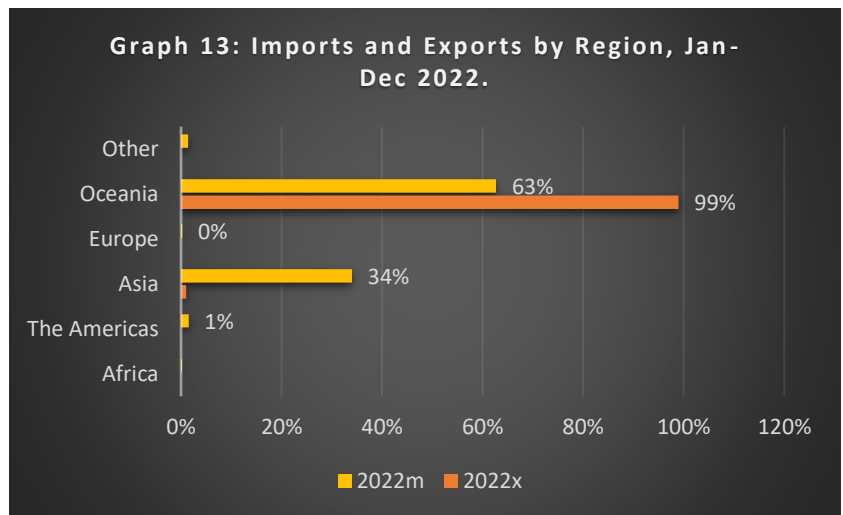
2021: In 2021, Fiji accounted for 89% of Tuvalu's total exports.



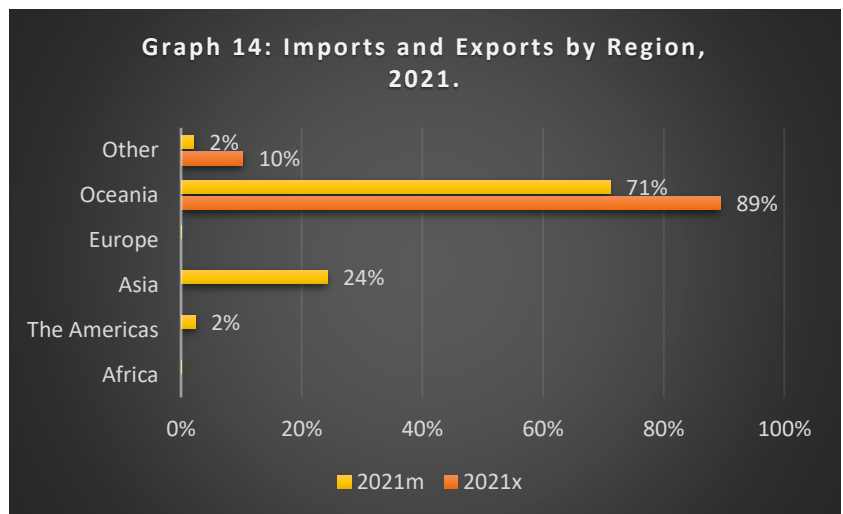
6. Trade by Geographical Region:

December 2022: In the analyses in Graph 13 alongside, Oceania dominated Tuvalu's trade association with the world with 63% of Tuvalu's total imports and 99% of Tuvalu's total exports.

Asia also played a significant role in Tuvalu's trade with 34% of total imports.



2021: The major region of exports and imports for Tuvalu in 2021 was Oceania, majority of the imports and exports from the Oceania were transacted with Fiji.
